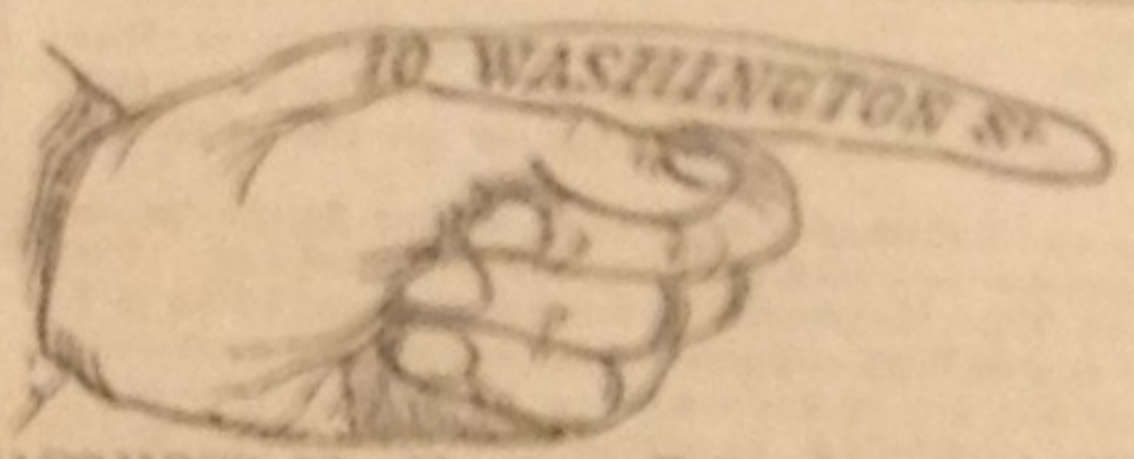

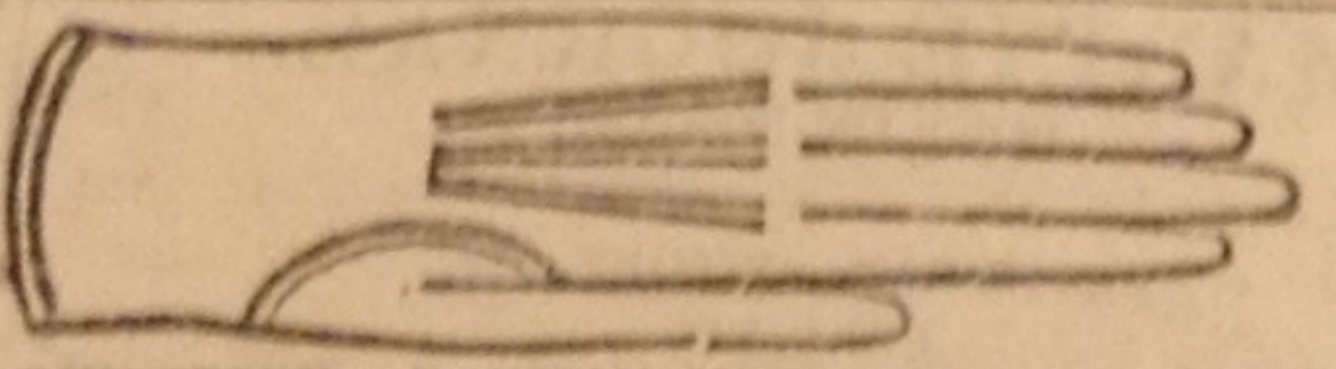

MASSACHUSETTS STATE PRISON.
PROPOSALS will be received at the Massachusetts State Prison until the 12th day of November next, for one year's supply of Rations for the Convicts, to commence on the 1st day of January next, to consist of the following articles, viz: 1 lb of good nutritious Beef, (the quality of which can be ascertained by calling at the Prison,) or 12 oz No 1 Pork. (Pork will be required but one day in each week) 10 oz Indian Meal, 10 oz of Rye Meal, and 2 gill Molasses for each Convict; and for every hundred rations 2 1/2 bushels Potatoes, 2 quarts Vinegar, 4 quarts Salt, 2 oz black Pepper, 2 quarts of Rye or Barley. Also for 2 oz of Beef extra per ration, if required by the Wardens. It is to be understood that the law authorizes the Warden to order fresh or salt Fish, one day in the week—the quantity for

FOREIGN NEWS.

IMPORTANT FROM EUROPE!
THE DEATH OF THE PRINCESS AUGUSTA—
ABDICATION OF THE KING OF HOLLAND—
CAPTURE OF BEYROUT BY THE ENGLISH.

The English Steamer Acadia, Capt. Miller, arrived here this morning at 8 o'clock. The Acadia left Liverpool on the afternoon of the 4th inst., and arrived at Halifax on the 15th, and ran from thence to this port in thirty one hours. She brought twenty passengers to Halifax, and seventy-two to Boston. The harvesting is rather dull—the money market somewhat depressed, and the cotton market without material alteration. The news in detail will be found below.

On the arrival of the Acadia at Halifax, a splendid suit of colors was presented to this noble steamer, by the members of the "Nova Scotia Philanthropic Society."

MUNICIPAL COURT.

Trial of the boot-makers for conspiracy—continued.—

The defence in this case was opened yesterday by J. S. Kimdall, Esq., who referred to a host of authorities relating to conspiracies and combinations in restraint of trade. The general ground taken by him is, that the English common law against such combinations was never acted upon in this State, and no statute has ever been passed against them; but on the contrary, they had existed from time immemorial in this Commonwealth, and had become a part of our common law.

Edward Blake, Esq., the last Secretary of the Suffolk Bar Association, was summoned to bring in the records of that now extinct institution, and Mr Parker consented to admit them as proving the historical fact that such a society existed, and as such might or might not go to support the general position taken by Messrs Rantoul and Kimball. Among the rules of the bar were the following :

“Nor shall any gentleman assume the care of any action originated in this county by a person practising therein, *not having subscribed these rules*, unless such person, being a regularly admitted attorney of the Court of Common Pleas, and not having been refused a recommendation for admission to the Supreme Judicial Court, or otherwise censured by a vote of the Bar, shall in writing, in a book to be kept for that purpose by the Secretary, have declared his assent to these rules, and engaged to observe the same. Nor shall any gentleman advise or consult, or be in any manner associated in any case whatever with any person practising in this county, who shall not have subscribed these rules, excepting such attorneys as aforesaid of the Court of Common Pleas.”

This society was dissolved in 1836, and a new society instituted, styled the Fraternity of the Suffolk Bar, who recommend the same rates of fee as the above bar rules made peremptory.
